Philmont does not make exceptions to this rule. 2010 participants must have been born no later than September 1, 1996.

I have reviewed the payment schedule above. I am aware that if I cancel, the following rules apply:

\$300 DEPOSIT IS NON-REFUNDABLE. If crew member drops prior to Sep 15, 2009, this fee cannot be refunded unless the member is replaced and the crew size does not change. The fee is refunded by the unit when a replacement is secured and is not refunded by the Contingent.

AFTER SEP 15, 2009 - If a crew member drops after Sep 15, 2009 and prior to Feb 15, 2010, there is a \$450 NON-REFUNDABLE FEE unless the crew member is replaced and crew size does not change. The fee is refunded by the unit when a replacement is secured; not by Contingent.

AFTER FEB 15, 2010 - There is NO REFUND. A \$450 NON-REFUNDABLE FEE PER CREW MEMBER APPLIES IF A REPLACEMENT IS SECURED. Any balance of fees is refunded by the unit when a replacement is secured and is not refunded by the Contingent.
